Re: Continuing activities of William Rockie Roper, an American State National on Nevada, to foment division within, and commandeer the Jurisdictional authority of the Nevada Assembly, a sovereign National State.

To all to whom these presents shall come:

I, a man Michael Trigger: Wilson, an American State National on Nevada, and a creation of Nature's God, standing on the land and soil of the organic states as a beneficiary of the American Public Law, and naturally possessing sovereignty in my own right, see #4713 International Public Notice: The Myth of the Sovereign Citizen <http://annavonreitz.com/sovereigncitizenmyth.pdf>, present this Notice of Claims and Testimonial, written in common American English and I have firsthand knowledge to declare as follows:

- 1) WHEREAS: William Rockie Roper, an American State National on Nevada, in his self-declared capacity as Coordinator on Clark County, has attempted to usurp the universally recognized jurisdiction of the Nevada Assembly by publicly claiming his intention to “rebuild” the Nevada Assembly on his own because the Nevada Assembly has “pretty much stopped doing all of that” in a recorded interview with an international body known as the Peacekeeping Task Force (PKTF) and their Executive Director Joe Hayse on September 19, 2025;
- 2) WHEREAS: William Rockie Roper, an American State National on Nevada, in his self-declared capacity as Coordinator on Clark County, has attempted to usurp the universally recognized jurisdiction of the Nevada Assembly by launching a website at <https://thenevadaassemblygov.land> for the apparent purpose of deceiving the public in asserting that this is an official website of the Nevada Assembly by posting our official Nevada Assembly seal without authorization or attribution

- 3) WHEREAS: William Rockie Roper, an American State National on Nevada, or his surrogate, in his self-declared capacity as Coordinator on Clark County, has attempted to usurp the universally recognized jurisdiction of the Nevada Assembly by registering the URL [thenevadaassemblygov.land](#), identifying as The Nevada Assembly Government, which he uses for all of his current official email correspondence, for the apparent purpose of confusing the public in the belief that he somehow represents the Nevada Assembly in some capacity;
 - 4) WHEREAS: William Rockie Roper, an American State National on Nevada, in his self-declared capacity as Coordinator on Clark County, has attempted to usurp the universally recognized jurisdiction of the Nevada Assembly by signing all of his email correspondence as Rockie Roper, Nevada Coordinator, The Nevada Assembly as a whole, in order to project the false belief that he represents the Nevada Assembly in the capacity of Nevada Assembly Coordinator;
 - 5) WHEREAS: William Rockie Roper, an American State National on Nevada, went through formal vetting with the Nevada Assembly Vetting Committee, which he failed to pass (see attached vetting report from the Nevada Assembly Vetting Committee), and was given direction to course-correct, which he declined to do;
 - 6) WHEREAS: William Rockie Roper, an American State National on Nevada, having failed Nevada State vetting, continues to represent himself as a vetted State Coordinator, citing inconclusive emails to justify this, even though he admitted during the September 19th PKTF meeting referenced above, that he never completed a normal vetting process with the Federation, let alone the Nevada Assembly;
 - 7) WHEREAS: William Rockie Roper, an American State National on Nevada, has engaged in a fraud perpetrated against the American State Nationals on the Nevada Assembly for the purpose of undermining the jurisdiction of the Nevada Assembly and its committees, works, and its People in an organized attempt to gain control of the Nevada Assembly jurisdiction and destroy the integrity of our Sovereign National State.

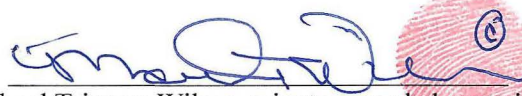

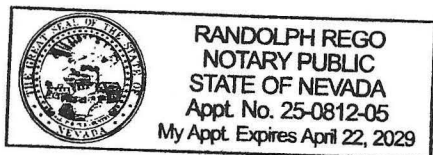
