Everyone that gets this email I am **requesting a reply** to this email so **Anna, Sue and I** can get a count of how many people are **not** getting emails for any of the Wednesday meetings **and/or** being **blocked** from being in any of The Nevada Assembly meetings. This is your chance to speak up and let Anna know the truth about the meeting problems. I will be listing all the things that has been ask of Sue and we all just get crickets from her. We never get responses to any questions from Sue. Sue, this is your chance to answer all the questions and save face with all the people in the assembly.

Let's start off with things we never get answered by Sue.

1. Where is all the recording for every meeting and why are they not available to the public for everyone to see. We demand to have a way to get to the documents. No more having secrets or hiding this information from people.
2. Why is Micheal Wilson still a Militia commander when the people in The Nevada Assembly voted him out of office and was told to not represent use without our approval. Then we get an notice back from Micheal saying he deny the people order and the people can't remove him.
