On November 21st and 24th, 2025, Rockie Roper, an ASN on Nevada and Clark County, sent an email out to numerous Nevada Assembly members, both in Clark County and throughout The Nevada Assembly, critical of the Nevada Militia Assembly's efforts to encourage firearms safety and proficiency training amongst its members. These emails had to be forwarded to me, even though I was mentioned in them, because Rockie has removed me from his email list (until recently, I had been receiving his emails). He conflated this as an effort to promote our members to "stockpile" arms and warned that this was a "defacto" trap that could get our members rounded up as "terrorists." As a result, Sue Hulsebus, our Nevada Assembly Coordinator, requested that I investigate this matter to determine if this did indeed pose a threat to our Nevada Assembly.

I did review the emails and conducted a further investigation into the activities of Rockie Roper, much of which has already been documented and is well known, and I concluded that we have a grave issue on Nevada that must be urgently addressed.

Contrary to Rockie's recent claims, it is entirely appropriate for the Nevada Militia Assembly Commander to conduct such investigations when requested to do so.

The following Report to the Nevada Militia (all members of The Nevada Assembly) is a presentation of the documented facts revealed in my inquiry.

It is time for The Nevada Assembly members to make a decision. It is safe to say that we all want to encourage collaboration and honesty as a central operating principle of our burgeoning American government. One based on evidence, vigorous debate, mutual respect, peace, and lawful representative government that calls out questionable activity and fraud when they occur. In short, we want to act honorably. It is time we openly choose that and put an end to any activity that hinders it.

Rockie Roper has based his entire claim to being an "appointed" Nevada Assembly Coordinator on one line from an email from Anna Riezinger...

"It is my understanding that Rocky stepped forward to assist as a Co-Coordinator, has been vetted, and so, accepted as a Coordinator in Nevada."



The operative part of this statement is *"It is my understanding"*. It is her understanding that he *"has been vetted"*. How did she arrive at that "understanding" when the entire issue of his successful vetting has been lawfully and factually debunked?

Anna says he has been "accepted", not appointed. So, who appointed him? Not the people on The Nevada Assembly, not The Nevada Assembly Vetting Committee, not Teri Sahm, the person who manages vetting for the Federation, not Joe Hayse, the Executive Director of the Peacekeeping Task Force (PKTF). Who appointed him as the Coordinator on Nevada?

Anna does not make a habit of imposing a Coordinator or a Co-coordinator on a state that has not supported them and that has not successfully passed State Assembly vetting. Rockie failed his state vetting because his prior actions demonstrated he was not a suitable candidate for such an important position of public trust, as he was causing unacceptable levels of division and chaos on the Assembly at that time.

Rockie initially claimed he had been "elected" as "Coordinator" by Clark County members. Prior to this, "County Coordinators" were referred to as "County Facilitators" on Nevada. Admittedly, the terms are a constant source of confusion for many. Perhaps it is time to put the question to the General Assembly for a vote.

Rockie's predecessor, Craig Schmidt, was a County Facilitator on Clark County. Craig underwent full Nevada Assembly vetting by The Nevada Assembly Vetting Committee and did so successfully.

Jill Horsely, County Coordinator/Facilitator on Washoe County, Nevada's second largest county, was also referred to as a Facilitator and also passed full vetting by The Nevada Assembly Vetting Committee years ago.

Rockie began referring to himself as a County Coordinator on Nevada early on, which was confusing to many of our members, as that term had not been the most recent one used on Nevada. Perhaps he adopted this term in response to the Federation's comments on other states' activities. Regardless, it was not a familiar reference here.

On Nevada, we typically vet our State Coordinators and our County Facilitators (Coordinators?) at the State level. We presently have at least two County Facilitators/Coordinators besides Rockie who have each passed State Assembly vetting, and others in their counties are rising who fully intend to submit to Nevada Assembly vetting.

Rockie has also stated that The Nevada State of the Union Assembly should not be required to vet these County "Coordinators". This is also a departure from the generally recognized and approved process on Nevada and would likely require a vote of the entire General Assembly to



change. Rockie seems to make unilateral decisions on such matters without regard to long-established practice or the accepted methods for changing our commonly agreed approaches to activities such as these on Nevada.

There was no Nevada Assembly-wide discussion about this; there was no vote by The Nevada General Assembly membership to adopt these changes; Rockie and his supporters simply announced it.

Since assuming this position, he has worked diligently to undermine the very State of the Union Assembly he professes to support.

Rockie claims that he is the one being constantly attacked. He forgets all of the documented and presented evidence to the contrary. Rockie has conspired against and disparaged our Coordinator, our Marshal at Arms, our Vetting Committee, our Oversight Committee, and anyone else who disagrees with what he has been up to for nearly a year. It is tiring and a waste of time, but whenever someone stands up and questions his actions, intentions or his validity as a 'coordinator, he labels them as attacking him. The only alternative is to be silenced by him and those who support him; this is not a viable alternative.

Rockie's latest initiative is the Union States Assembly, wherein he appears to be the sole spokesperson. The Union States Assembly is a coordinated effort by County Coordinators/Facilitators who collaborate on issues faced by the participating counties. They meet as a group, elect a Chair, and deliberate among themselves to determine what best suits their collective needs. They are not county meetings (yes, the county can be considered one of the "Union States", but one county does not make a Union State Assembly), and they are not conducted by members at large. While anyone can join and listen to these meetings, they are conducted by Nevada Assembly vetted and seated County Coordinators/Facilitators. It is well established that, by any reasonable definition, Rockie has never conducted such an Assembly meeting of County Coordinators/Facilitators and has no authority to do so, as he is not a state vetted Coordinator/Facilitator himself. Through this mechanism, he is trying to justify the creation of committees, state-level functions, websites, and new email addresses that are neither appropriate nor condoned by anyone other than himself and his supporters.

Rockie and his supporters have effectively cut off Clark County members from the rest of the (actual) Nevada Assembly. They conduct regular meetings railing about how bad The Nevada Assembly and their elected representatives are, but when pressed to provide any evidence of their unprovoked accusations, they always come up empty. They have gone further by regularly impugning The Nevada Assembly and its members on international forums and meeting spaces, all without the burden of any evidence or facts.



I am not happy about this. I would rather spend my time on just about anything else that would benefit the Nevada Militia Assembly and The Nevada General Assembly at large, but this can no longer continue. This has to be addressed, and the People of Nevada must speak up in order to determine the future of our State of the Union.

It's like dealing with the mainstream news. When you are told blatant lies by them, how do you discover the truth? You carefully examine, question and probe every item of evidence presented to back up that narrative before you decide to embrace or reject it.

That has been done in this case, and the facts and unrefuted evidence have been presented.

FACT: thenevadaassemblygov.land URL, which is used by Rockie Roper and many of his supporters in emails and at their website, is in no way affiliated with The Nevada Assembly and is being used as a deceptive and divisive device to undermine the autonomy and jurisdictional identity of the only officially recognized Nevada Assembly. If this is genuinely an innocuous URL used for the Union States, why is it called the-nevada-assembly-gov-.land?

FACT: In February of 2025, an effort at reconciliation was begun by the State of the Union by bringing in ASN John Butruccio on Maine, a well-known conflict-resolution expert who has worked closely with the Federation and other American Nation States to mediate discussions among the interested parties and offers popular leadership trainings. By April of that year, it was underway. This eventually devolved into refusals to return State of the Union property and more unsubstantiated accusations by Denise Mraz about John during an international call. The conflict-resolution talks were canceled due to these personal attacks against John and Denise's unwillingness to speak to him. The Nevada Assembly, through our Coordinator, has tried to resolve these issues with Rockie et al, but to no avail.

FACT: In April of 2025, The Nevada Assembly Oversight Committee investigated and asked Rockie Roper and Denise Mraz to substantiate their claims of malfeasance, criminal activity, and dereliction of duty against Sue and Doug Hulsebus. They would not. It was therefore concluded that their claims were false as no evidence was produced when requested. This has not stopped them; Rockie's response is to create his own Nevada Assembly Oversight Committee.

FACT: William Rockie Roper never stood for a vote by The Nevada General Assembly membership at large to represent The Nevada Assembly as a Co-coordinator and failed his State Vetting as a County "Coordinator". This is undisputed and proven.

FACT: In May of 2025, Sue issued an urgent request for a poll because Rockie Roper told the Global Family Group (GFG) Bank that he had been voted by The Nevada Assembly unanimously to be the GFG Nevada Coordinator contact for the bank. In the email of May 30, 2025, Sue



asked if anyone had heard about this unanimous election Rockie claimed had occurred, and to indicate (1) “Do you approve Rockie Roper as The Nevada Assembly State banking contact for GFG?”, and (2) “Do you approve Rockie Roper as The Nevada Assembly State Coordinator? The results showed that no one was aware of any General Nevada Assembly vote to make Rockie our State of the Union bank contact, and the overwhelming response to the questions presented was NO! It was yet another fraud.

FACT: Anna Riezinger never appointed William Rockie Roper as a State Coordinator; she merely assumed he had fulfilled all of the necessary aspects of being a State Coordinator and accepted that on its face.

FACT: Rockie Roper has used deceptive and fraudulent means to represent himself in various ways to assume a mantle of authority he simply does not possess. He has signed his “official” emails and other correspondence as Nevada Coordinator – The Nevada Assembly as a Whole, Co-Coordinator, Clark County Coordinator, and Coordinator, all to justify his unilateral dictates over The Nevada Assembly. He has used various email addresses during this time, including rockie.roper@tccnva.org (tccnva = The Clark County Nevada Assembly), coordinator@thenevadaassemblygov.land, and rockie.roper@thenevadaassemblygov.land, which creates confusion and doubt amongst the public, and undermines the official Nevada Assembly.

FACT: Rockie has publicly stated that he has undertaken an effort to personally rebuild The Nevada Assembly because those on The Nevada Assembly responsible for this work are not doing their job. He clearly has no idea how insulting this is to all of the men and women on Nevada who have poured countless hours into our Nevada Assembly work. He further admits that he and his supporters are creating State Assembly-level positions and committees and filling them with elected members, even though no Assembly-wide votes are taken or carried out.

FACT: In a September 2025 interview with the PKTF, Rockie admitted that he has never completed a standard Federation recorded vetting interview and that all he has received is the above-referenced email from Anna Riezinger as proof that he is a Coordinator on Nevada.

FACT: Rockie Roper is quoted quite recently as telling Sue Hulsebus “Let me be clear, I do not want to help you build anything anymore. That is why I stopped going to your meetings”. Prior to this, he said that Sue’s refusal to invite him was the reason he stopped attending “her” meetings (official Nevada Assembly meetings). Regardless, he has made it clear that he is no longer cooperating with The Nevada Assembly Coordinator, who has performed her duties for years.



FACT: Rockie has admitted that he is running one Nevada Assembly and that Sue is running the other. There is only one official Nevada Assembly. Whatever Rockie is referring to is outside that official Federation-recognized assembly. To create a second unrecognized Nevada Assembly is seditious behavior.

FACT: Rockie and a few Nevada Assembly Recording Secretaries have fraudulently registered new American State Nationals under Rockie's name as State Coordinator on false Nevada State of the Union documents using deception and fraud to undermine the jurisdictional authority of The Nevada Assembly.

In a new finding as a result of this inquiry, prompted by Rockie Roper's emails of November 21st and 24th, 2025, we have uncovered yet another serious concern regarding the integrity of The Nevada Assembly.

It appears that Rockie and these others have been registering new American State Nationals who have changed their status, by recording them, not through Nevada Assembly official channels, but by creating an alternate Nevada Land Recording Office and registering these new members there under Rockie Roper as the Nevada State Coordinator (see the evidence that appears in the Addendum at the end of this report). Our legitimate Nevada State Coordinator, Sue Hulsebus, had no idea this was going on and therefore may not have been able to add these new members to the official Nevada Assembly distribution list. No one on The Nevada Assembly was ever consulted about this, let alone voted on this or approved it.

Sedition

Sedition is the crime of inciting, encouraging, or organizing resistance or rebellion against the lawful authority of a state or government, typically through speech, writing, or publication, without necessarily involving violence or treason.

These well-documented activities by Rockie Roper, Denise Mraz and others constitute sedition against The Nevada General Assembly. Sedition is a serious claim, but given the facts, there can be no other way to define this. As such, it falls to me, as the Nevada Militia Assembly Commander, to bring these facts forward to The Nevada General Assembly membership, our Nevada State Militia, to determine what should be done to protect ourselves from this blatant rebellion. It is clear that Rockie and his supporters want this all to stop and for our membership to just look the other way. We are all sick and tired of the public back-and-forth this has generated. Recall, however, that this has been initiated and fomented by one side throughout this debacle. Prior to December of 2024, The Nevada Assembly was peaceful and collaborative in its efforts to stand the State since 2019. This will not stop until a clear way forward is addressed and put into action.



These are the facts as presented to you, The Nevada General Assembly membership, by me as your Nevada Militia Assembly Commander. Now, it is up to you, the Assembly, to self-govern and resolve this. It is not up to me or anyone in elected or appointed office to tell you what to do.

There have been clear violations of public trust by Rockie Roper and others involved. We all have a responsibility to look at the facts and guide the future course of this Assembly. It is my fervent hope that the good People on Nevada will take this matter seriously and put an end to this seditious conspiracy immediately. To do otherwise is to risk the very principles upon which we purport to live by and desire to achieve, to establish a fully functional and cooperative self-governing free state.

EXECUTIVE SUMMARY

We have established that there is ample evidence that implicates several American State Nationals on Nevada in actively participating in and promoting insurrection and rebellion against the Nevada State of the Union Assembly.

Known Activities

ELECTION FRAUD

Claims of state-wide votes and decisions that never occurred or had different outcomes:

- Rockie was never voted upon as a Nevada State of the Union Co-coordinator in any state-wide vote conducted.
- Rockie failed his Nevada Assembly vetting for the County "Coordinator" position, ignored the results, and refused to take the recommended corrective action to achieve proper vetting. Later, he claimed parties outside the Nevada State of the Union had vetted him.
- Rockie falsely claimed he was unanimously voted to represent the Nevada State of the Union as the sole contact for the Global Family Bank on Nevada.

WIRE FRAUD

The use of deceptive and unrecognized or unapproved Universal Resource Locators (URLs) in order to conduct what appears to be official Nevada Assembly business without permission:

- The use of emails designed to appear as official Nevada Assembly communications.
- The use of thenevadaassemblygov.land URL in order to deceive the public and to imply affiliation and endorsement of The Nevada Assembly without consent.
- The signing of electronic communications with official titles not earned or conveyed in an effort to project official authority.
- The use of the Official Nevada Assembly Seal in an unauthorized manner in order to deceive the public.

DOCUMENT FRAUD

The recording of American State National status change documents in an unauthorized manner:

- The creation of a Nevada Land Recording Office recording stamp designed to mimic the official Nevada Assembly recording stamp, which was never voted on or approved by The Nevada Assembly.
- Falsely recording status change documents under an unapproved and unauthorized Nevada State of the Union Coordinator email address.



ADMINISTRATIVE FRAUD

Public admission of attempts to create a second, unrecognized Nevada Assembly of Nevada:

- Multiple meetings with the declared purpose of standing an alternate parallel Nevada Assembly.
- The creation of multiple duplicate state-level committees and structures not voted upon by The Nevada Assembly membership statewide.
- The election of Nevada State of the Union personnel who were not recognized or voted for in a statewide election (State Militia Commander)

UNSUBSTANTIATED RUMORS, GOSSIP, AND ACCUSATIONS AGAINST ELECTED AND APPOINTED NEVADA STATE OF THE UNION OFFICIALS AND OTHERS.

Claims of malfeasance, malpractice, criminal activity, conspiracy, and character assassination without evidence:

- Multiple claims of unproven criminal and dereliction of duty activity on the part of The Nevada Assembly Coordinator and Marshal at Arms.
- The public accusation that The Nevada Militia Commander was engaged in unlawful encouragement of arms stockpiling and potentially terrorist activity, leading to vulnerability of a de facto raid and arrests of our Militia members.
- Disparagement and threats of legal action against individual Nevada Assembly Vetting Committee members.
- The public disparagement of a dispute reconciliation expert in public international forums and the refusal to participate in conflict resolution activities.
- Refusal to provide evidence to an official Nevada Assembly Oversight Committee investigation.
- Multiple instances of disparaging comments and unfounded accusations against The Nevada Assembly and its members and elected or appointed officials in various international forums and meetings.

All of this leads to the inescapable conclusion that The Nevada Assembly is under sustained and constant threat from elements and people within our own institutions and membership.



ADDENDUM

We now have evidence that some Nevada Assembly Recording Secretaries are recording their official documents with fraudulent stamps and false recording information. The following is a screenshot of the official recording stamp approved by The Nevada General Assembly.

See the difference? There is no approved "Nevada Land Recording Office". Subtle differences in seal font do not obscure the apparent intent to portray this as an official Nevada Assembly Recorder's stamp in the example above.



This is a recording made with Rockie Roper's coordinator email listed as the State Coordinator email address. He is not a Nevada State Coordinator.
