I am in receipt of your latest email entitled "If you want here the people", and I want to mention that I am not "trying to take over and control" anything. I never think in these terms, and the roles I have stepped into, on my County "Union State", as well as on Nevada, are always taken with an understanding that I am not "taking over", or "control[ing]" anything. I endeavor to represent those who have entrusted me to represent **their** interests as it affects the greater membership in both venues.

The Union States issue has become a more prominent issue of late, as you have made very clear in recent months, and those of us who are interested in promoting this concept have begun to work together to facilitate the development of our counties in this regard. We have agreed to begin meeting regularly in order to do so. We have noticed that you have been conducting "Union State" meetings of your own for several months, but, until the announcement of an actual Union States Assembly

meeting, to which you, as a Federation-appointed Nevada Co-coordinator tasked with the role of coordinating the rise of the Union States on Nevada, and any other State vetted County (Union State) Facilitators have been invited to attend. We are permitted to "assemble" in any way we believe will best support this worthy effort, and considering the fact that a number of us who are Nevada State vetted County Facilitators have never been contacted by you directly until now, only supports moving the process along in order to include those that have been left out.

In fact, myself and several other County Facilitators were excluded from your meeting announcements entirely until we invited you to this meeting at the end of January. Jill Horsly has been a State vetted County Facilitator much longer than you have been visible on this issue, and represents the second largest County on Nevada, and yet, has never had you reach out to her on this topic.

In closing, we sincerely hope you will consider joining our efforts to stand the counties on Nevada. We welcome your constructive input, and we consider this a very positive step in the right direction in standing our counties on Nevada. One would assume you would wholeheartedly celebrate this effort rather than assume that I, or anyone else, is attempting to wrest control from you (or anyone else).
