Rockie,

I received your email and I understand why you're asking for help with what's going on in Nevada.

I also want to address what was brought up by the Affiliate office. They are correct that matters involving the appointment, vetting, recognition, removal, and oversight of Coordinators, Marshals at Arms, Recording Secretaries, and the operation of the State of the Union Assembly fall under the Fiduciary's office. CMS is not going to step into that role or make decisions that belong to the Fiduciary.

However, some of the things you are alleging go beyond a disagreement over who holds a position or who should be recognized.

You have alleged interference with Assembly websites and email systems, problems involving access to records, possible misuse of authority, harassment, and someone contacting your personal internet provider and causing your services to be shut down. Those are the areas that concern me from an investigative standpoint.

If CMS moves forward with an investigation, we will be looking at the conduct itself and the evidence supporting it. We are not starting from the position that anyone is guilty. We need to find out what actually happened.

Depending on what the evidence shows, the investigation could involve breach of trust, abuse or misuse of authority, interference with Assembly operations, improper control or withholding of Assembly records or property, fraud or intentional misrepresentation, retaliation, harassment, knowingly false statements, coordinated wrongdoing, or the hiding, changing, destroying, or fabrication of evidence.

Again, I'm not saying any of those things have already been proven. That's what an investigation is for.

The June 27, 2026 vote involving Michael Wilson also needs to be documented. Whether that vote removed him or affected his position is something for the proper Assembly and Fiduciary process to determine, not CMS.

But if the vote becomes relevant to determining whether someone later acted without authority, then we need those records. Please preserve the meeting notice, minutes, quorum information, vote count, recordings, and anything else connected with that meeting.

I also want everything you have concerning the websites, domains, email accounts, and Assembly records. We need to know who controlled them, who made changes, when the changes were made, and what happened.

The issue involving your personal internet provider needs to be kept separate and documented as well. If someone contacted your provider, send whatever you have showing who made the contact, what was said, what the provider did afterward, and how it affected you.

Please save everything. Emails, texts, screenshots, recordings, meeting minutes, notices, provider emails, domain records, and anything else you believe supports what you've reported. Don't delete or change anything.

The men and women named in your complaint will also have the opportunity to respond and provide their evidence. That's only fair. If we're going to investigate something, we need to hear both sides and let the evidence tell us what happened.

I also want you to understand something that applies to every complaint we receive.

If something you reported can't be proven, that does not automatically mean you filed a false complaint. Sometimes a man or woman reports something they honestly believe happened and the evidence just isn't enough to establish it.

Knowingly making something up is different.

If the evidence shows that anyone knowingly made false accusations, created or submitted false evidence, hid evidence, changed evidence, or deliberately gave information they knew wasn't true, that can become part of the investigation as

well. The same standard applies to everybody.

I'm not interested in picking sides in Nevada. I want to know what happened.

The governance issues need to stay with the Fiduciary. The allegations of actual wrongdoing need to be separated from those issues and looked at based on evidence.

If we're asking the People to believe in accountability and due process, then we need to practice it ourselves.

Please organize what you have by each allegation instead of sending everything together. That will make it much easier to put the timeline together and determine what needs to be investigated.
