

This is the response to Michael Wilson's document "THE ALLEGATIONS AND THE RECORD" dated 4 September 2026. I am setting the record correct with what was really said, and the words are not twisted to mean something else.

Item number One – "What was said." A notice went out to Michael Wilson with these exact words. "This is to inform everyone that Michael Trigger Wilson has been voted out of the "The Nevada Assembly" unincorporated for holding no position and does not have any right to represent The Nevada Assembly unincorporated." I have never addressed Michael Willson as the Militia Commander, so the statement is misleading. "and that he is the "Militia Commander"". Michael goes on to say how he has been voted in with dates like 30 May 2025 and has never showed Meeting documents, video of the meeting, or the election document.

Next part of this statement is the "vote was not of this assembly". We want to know what assembly he is talking about because there is only one assembly and that is all the ASN's in Nevada. He goes on to says the men and women where never told it was happening. The email from the Co-Coordinator Tamara Amaral was sent out to everyone on June 26th 2026 with the agenda to talk about the Militia Meeting and what Michael was doing. Michael got that email. Item number Two - Let's explain the conflict of interest here. Let's first talk about Michael Wilson working at the District Attorney and how he has used his role or position with the District Attorney. We talk about privacy and that the people are not allowed to use the information on the LRO or document with other sources. Well as Michael has said in this document in Section Five, he tried to serve me with papers with a "licensed professional" that he got from the District Attorney office. This was a privacy breach on the assembly because I did not give the assembly or Michael Wilson the use of my information I recorded in the LRO by Teri Sahn. Then we talk about Doug and Sue being married and Doug working with the Voluntary Fire Dept. When there is any conflict with the coordinator Sue, right off Doug takes her side in the matter and tries to discredit the one who makes the complaint. This is the conflict because there can't be any bias on Doug's and Sue's part.

Item number Three – The statement made about Sue "has not been vetted correctly" came from Anna in a text. Let's talk about Tamara Amaral's vetting and being approved by Anna. First, the vetting from the Continental Marshal's report sent to all the coordinators in Nevada. Item number Four – Let's correct what was said about Teri and the LRO she maintains for the federation to use. I made a comment in the meeting that we would use the LRO from Teri, if she would give us access to do so. So because we do not have access from Teri to be able to record people back on the land and soil, I've created an LRO for Nevada, and it was voted in by the People to use that LRO for now. The vote for that was held on May 30th 2026 with The Nevada State Business meeting starting at 4:03 p.m. The minutes in this document

Item number Five – As we talk about this in item number Two with people in the assembly have access to the Peoples information is a privacy problem and the people in the June 27th 2026 meeting addressed this by confirming Michael Wilson needs to be removed from this information and is not allowed to use the people's information. This has not stopped because Sue gave him full access to everything in the assembly. Why? We don't know. We've been asking for an explanation.

Item number Six – Still to this day I do not get any emails from Sue or Michael except notices. No assembly meetings at all. I had to get a copy of this document from one of the people in the assembly, or I would not know about it. Michael talks about not answering his notices like this one. It is hard to answer anything if you are blocked for the assembly. Michael says I am a subscriber on the assembly, and I still do not get any proof except not getting email or invites. Michael talks about the Union State Assembly and that is one of their tactics to stop any progress of building the assembly in any faction they try and copy what you are doing and then take over and shut it down. An example of this is when they can't take it over or control it they vote to remove the part of the assembly and Anna has to step in and tell Sue to stop this nonsense. This is the email sent to Sue from Anna.
