Description of your query: Dear PublicDomainRegistry.com Abuse Team,

I am writing in response to the recent domain abuse complaint submitted by Sue Hulsebus and Michael T. Wilson regarding the domain <https://thenevadaassemblygov.land/>. I respectfully request that you review the facts below and restore the domain to active status, as there is no evidence of harm, fraud, or bad faith associated with my use or operation of this domain.

1. No Harm, Fraud, or Deceptive Use

– Legitimate Purpose:

The domain <https://thenevadaassemblygov.land/> has been used solely for peaceful, lawful, and informational purposes. It serves as a platform for a community of individuals interested in land and soil jurisdiction topics. There has been no intent to impersonate, defraud, or mislead the public or members of any other organization.

– No Impersonation:

Nowhere on the website or in communications is there a claim to be the official Nevada Assembly at nevadaassembly.org. The domain is clearly distinct, and any references to "Nevada Union State" or similar terms are used in a context that is separate from the complainant's organization.

– No Fraud or Unauthorized Representation:

There has been no fraudulent insertion of contact information into official records, nor have any unauthorized or deceptive stamps been used. All communications and documents are transparent and traceable to their actual source.

– No Deceptive Trade Practices:

The use of "gov" in the domain is not intended to mislead or imply governmental authority, but rather to reflect the subject matter of land and soil jurisdiction, which is a common topic in public discourse. There is no evidence that any member of the public has been confused or harmed as a result.

– No Diversion or Defamation:

The website does not divert traffic away from nevadaassembly.org, nor does it contain any defamatory or misleading statements about the complainant's organization.

2. Pattern of Harassment and Instigation by Complainants

– Personal Dispute, Not Policy Violation:

The complaint is part of an ongoing personal dispute instigated by Sue Hulsebus and Michael Wilson, who have a documented history of making unfounded and defamatory claims against me. Their actions are motivated by internal organizational politics, not by any actual harm or abuse.

– No Evidence of Bad Faith:

The complainants have failed to provide any verifiable evidence of actual harm, fraud, or confusion caused by my domain. Their allegations are speculative and unsupported by facts.

– Prior Attempts at Resolution:

I have always been open to dialogue and resolution. The narrative of "evasion" is inaccurate; I have not received any legitimate or properly served legal notice requiring my response.

3. Supporting Documentation

– Background Check:

My official ClearHire National & County Background Check (Jan 28, 2025) is 100% clear, with no criminal or civil issues.

– Peer and National Recognition:

I have been recognized by peers and national organizations as a model county organizer and have always acted in good faith.

– No Legal Actions or Judgments:

There are no court judgments, UDRP decisions, or legal findings against me or my domain.

4. Request for Immediate Restoration

Given the facts above, I respectfully request:

– Immediate restoration of the domain https://thenevadaassemblygov.land.

– That any future actions regarding this domain be based solely on documented, verifiable evidence, not on hearsay or personal disputes.

– That PublicDomainRegistry.com uphold its commitment to fairness, due process, and the protection of its clients from malicious, unfounded takedown requests.
