This is a coordinator of the Nevada Assembly and I am requesting you to take the suspension off of our domain thenevadaassemblygov.land.

Obviously, you're not familiar with our structure or how this assembly runs.

Michael Wilson does NOT have any authority to speak for the Nevada Assembly. We have explained this in previous email.

If this suspension is not lifted within 7 days, we will be placing a lien on your company and getting a lawyer to sue for damages to all parties involved.

I have tried to communicate nicely and let you know that the parties in this attack on the assembly have been taking care of on our part. The other coordinator Sue Hulsebus has been placed on suspension for her involvement in this attack.

Also, if you look at the logo that you have pointed out, they are not the same.

One reads The Nevada Assembly - Land and soil jurisdiction and the other reads

The Union State - National Jurisdiction. They are not the same logos. If you think the picture of Nevada is a reason for suspension then you are mistaken. There are different jurisdictions in every state.

Again, these are the same assembly just 2 different division. One is State and the other is the counties.

Please, remove the suspension or you will force us into a lawsuit with your company and all parties involved.

Who We Are:

We are a group of men and women residing in Nevada who work together as the Nevada Assembly. Our assembly is part of a greater national effort, with Anna Von Reitz as the founder and coordinator of assemblies across all states. Our purpose is to facilitate communication, collaboration, and community projects within Nevada and with other state assemblies. We are not a corporation or a formal organization; rather, we are a voluntary association of Nevada residents.

Purpose of the Domains:

The domains in question are essential tools for our internal and public communications. They serve as our primary means of sharing information, organizing meetings, and coordinating assembly activities throughout Nevada.

Background of the Dispute:

Recently, two individuals, Sue Hulsebus and Michael Wilson, attempted to prevent members of the Southern Nevada assemblies from participating in our group activities and accessing our resources. This has caused significant disruption to our assembly's operations.

Our understanding, as directed by Anna Von Reitz, is that assemblies are not to be incorporated, and any such claim would be contrary to our established rules and procedures.
