Dear Anna,

I feel the need to clear up a few things surrounding your determination to place your lead Nevada State Coordinator on suspended leave for the month of April.

On March 7, 2026, you wrote an email to Rockie Roper and Sue Hulsebus, both Nevada Coordinator and Co-coordinator, that the Federation has recognized on The Nevada State of the Union and The Nevada Union State of Clark, respectively, the following;

Subject: *One Error Does NOT Justify Another*

Rockie— *look at your urls that end with .land.*

Anything bought or owned by the county assembly should end in .soil not .land.

Land is the international jurisdiction. Soil is the national jurisdiction of the counties.

So you arguably need to change that URL extension to prevent confusion.

Sue— *you have gone too far. Seeking to sue Rockie personally instead of pointing out a simple error is hateful and un-American.*

If I ever catch you doing something like this again to any Nevadan who is claiming their birthright status you will be out on your ear quicker than scat.

I am not going to keep on begging you to do the right thing and act as a guide to HELP the county assemblies find their feet as separate independent bodies.

The Counties are NOT supposed to be under the direction of The Nevada Assembly but you do owe them protection and assistance figuring out their role and jurisdiction.

Not process servers.

On March 23, 2026, just under two weeks later, you wrote;

Sue— *I warned you and am now suspending you from operating as The Nevada Assembly Coordinator for the entire month of April. The Union state that exists at the County level has every right in the world to use thenevadaassemblygov.land domain name and you have neither right nor reason to stop them.*



You are way off track with this whole attitude.

This was in response to an email from Rockie Roper that claimed;

Sue and Micheal are not stopping. They just had my domain

(thenevadaassemblygov.land) shut down and now I have to fight to get it

up again. They spent 1500.00 dollars out of the Nevada Assembly treasury to

shut us down here in Clark County.

Please stop these people from attacking us!

It may interest you to know that our Nevada State Lead Coordinator, Sue Hulsebus, despite what you have obviously been led to believe, had nothing to do with any of this. This was an action that was openly deliberated by our status-changed American State Nationals and supported by the People of Nevada in a transparent and lawful manner through a series of open Official Nevada Assembly meetings over a long period.

Then there is this statement “*The Union state that exists at the County level has every right in the world to use thenevadaassemblygov.land domain name and you have neither right nor reason to stop them.*” Which contradicts your prior directive for Rockie to lose the .land URLs, and, with all due respect, that is patently false as our lawfully filed and successful Digital Millennium Copyright Act (DMCA) air jurisdiction complaint proves. (see, attached complaint and exhibits).

We have also not spent \$1,500 to exercise our rights in this regard, as Rockie has stated. We were authorized by the membership to spend that amount, but we pursued an avenue to stop this abuse at no cost.

We simply made the case to the domain provider of clear cybersquatting and copyright infringement, and they (an uninterested party) agreed (see attached).

This issue has been going on for many months, and every reasonable avenue has been pursued, according to Federation guidelines, many of which you authored, as to how to proceed under these circumstances and resolve this issue peacefully.

We have all of the receipts. We documented everything. We are happy to provide you with any additional information you may require in order to respond to this issue in an informed manner, should you care to do so.

I would also like to point out that no one is “suing” anyone. An effort was made, at the direction of the Assembly membership, to advise Rockie Roper, the most prominent user of the offending domain, thenevadadassemblygov.land, to cease and desist in its use as it clearly violated The Nevada Assembly common law copyrights, jurisdiction and trademarks. And was causing undue



confusion and harm to The Nevada Assembly. He repeatedly and successfully avoided receiving this notice, even though it was openly discussed in our Nevada Assembly meetings, and there is every reason to believe he knew what the Cease and Desist Letter addressed. He has referred to other aspects of those same meetings in his posts while using the offending domain.

Contrary to what you may have heard, no one is "attacking" Rockie. We are simply asking, formally, that Rockie quit portraying his work on the Union State of Clark County as Nevada State of the Union business.

I recently conducted a Nevada Assembly Militia meeting where I laid out quite clearly what the jurisdictional boundaries on Nevada are, and I made it clear that it is of no concern to the Nevada State of the Union what the Union State of Clark County does within its Soil jurisdiction boundaries. That is for the American State Nationals domiciled on the Union State of Clark County to decide. But this issue has crossed jurisdictional boundaries into the Land jurisdiction of the State of the Union and Nevada, and I am obligated to address it, as directed by the Nevada Assembly members.

Rockie is still sending out emails to the entire state declaring that "Sue" is blocking him again. Using a new domain - thenevadaunionstategov.land domain. Another .land domain that he, or one of his associates, clearly purchased earlier. We have no problem with the domain, should he decide to continue to use it, although it uses the very .land designation that you yourself cautioned against. What is disconcerting is that his website still clearly identifies as a State of the Union authority, even today.

Of note, there is not a single reference link to the actual Nevada State Assembly on this website. You will also notice that the seal in the header at the upper left depicts the entire Nevada State of the Union, which is deceptively similar to our Nevada General Assembly seal used on our own website.

In all, you, of course, are free to do whatever you like with regard to "Coordinators" that you appoint to the Nevada State of the Union; however, you should know that the Assembly members here are growing increasingly fatigued by the apparent inability of you to manage them appropriately in order to minimize conflict and division.

We expect them to stay in their jurisdictional lanes and quit causing division and chaos on Nevada.
