

Rockie,

I regret to inform you that the vetting committee has voted unanimously to disapprove you as the Clark County coordinator. This decision was not made lightly. We all have a great deal of appreciation for your willingness to step up and we find many qualities you possess that would be beneficial as a Clark County Coordinator. I'm happy to inform you that we have unanimously decided to give you an opportunity to course correct within the next four weeks. Once course correction is complete, we will reconvene to vote again. The corrections we are requesting are enumerated below. If you have any questions, please feel free to reach out. We are a team on Nevada and we look forward to getting back to being a peaceful and productive team.

There are 3 main categories we look at when evaluating a candidate per Anna's article "A Message to All State Assemblies."

- (1) basic eligibility for the job in question;
- (2) past criminal history that might affect job performance;
- (3) substantial conflicts of interest

Item 1: You appear to meet basic eligibility requirements as your documents are in order and green card receipts from mailing were provided.

Item 2: We found documents pertaining to a felony conviction for kidnapping and robbery. We weren't able to verify this information and it did not weigh heavily in our decision since the time was served and we are unaware of any current issues related to this incident .

Item 3: We agree unanimously that course correction is required so you can function productively with your fellow Coordinators and help us uphold the basic rights of all Americans on the Nevada Assembly . There have been multiple attacks against the State Coordinator on Nevada. It appears that you were at least indifferent if not fully supportive of these attacks. This creates a substantial conflict of interest since as a County Coordinator you will be working closely with the State Coordinator. A level of cooperation and respect is required to accomplish our objectives. Another issue is the rights of your fellow Americans on Clark County and on the State have been violated. Freedom of speech and right to self-govern are basic rights that have been substantially impacted. As a Coordinator you need to be impartial and protect the rights of all your fellow assembly members equally. It does not appear that you have managed to remain impartial. The assembly voted to put Denise on a time out for many instances of unacceptable behavior. Although on a few occasions you have admitted that her actions were unacceptable, you continue to allow her to not only remain active on the Clark County assembly but to run your meetings and assume positions she has not been vetted for through the appropriate channels. In addition, there are materials that have the Clark County seal on them or have been distributed on behalf of the men and women on Clark County that your fellow

men and women on Clark got no opportunity to have input on or approve. As explained previously, when an Assembly member is denied the right to have input on something presented in their name their freedom of speech and right to self-govern are violated. As Clark County coordinator you would be expected to have the paramount interest to protect the basic rights of all your assembly members equally. Sometimes difficult decisions must be made. Therefore we suggest the following items for course correction:

1. Provide recordings of all recent Clark County Meetings to the vetting committee within three days of beginning the course correction process.
2. Provide a weekly update to the State Marshal-at-Arms, Doug Hulsebus demonstrating progress towards implementing the course correction items.
3. Meet weekly with your fellow State and County Coordinators for the purpose of planning how we will work together to get our four pillars built and reduce conflict in the Assembly.
4. Cease all secret meetings. Cease all "State" level meetings where only a select group of Assembly members are invited and State level committee members are excluded. For example recent "Business Assembly" meetings. We don't operate in secrecy.
5. The Clark County assembly office located at 800 North Rainbow Boulevard, Suite 161, Las Vegas, Nevada 89107 must be shut down. The Assembly never was given the opportunity to vote on establishing an office, the location, and who has access. Only Assembly members who have been vetted through the approved procedure and committee should have access. If Denise wishes to maintain the office, she may do so but no Assembly business shall occur there and no Assembly funds should be used to pay for any expenses associated with running the office.
6. All Assembly property stored at the office must be returned to an elected member of The Nevada Assembly like our State Treasurer immediately including but not limited to:
 - a. All Nevada Assembly records: hard copies and electronically stored records.
 - b. All Nevada Assembly assets including cash, metals, cashier's checks, computers, furniture, and equipment.
7. You must ensure that access and control of all websites and social media claiming to be Assembly websites including but not limited to all social media accounts and the website

<https://www.theccnvassembly.org> must be immediately returned to the control of an elected and properly vetted Nevada Assembly Member.

8. Posting inflammatory rhetoric on public sites is forbidden and shall be addressed in an appropriate manner. We suggest you impose an appropriate time out from the County Assembly for the individual responsible for this unacceptable behavior. 6 months seems appropriate.
9. Denise is to immediately cease producing any written materials in the name of the Clark County Assembly or Nevada Assembly including but not limited to notices, marketing materials, post cards, and posters . Anything sent on behalf of The Nevada or Clark County Assembly by Denise is to be retracted immediately. Only if The Nevada Assembly or Clark County Assembly has approved a communication or notice should that be distributed - otherwise everything else is null and void. Direct Denise to retract and destroy everything distributed in the name of Clark County and/or the Nevada Assembly. She should be informed that her timeout will not end until she does so.
10. Any un-vetted or unelected individual cannot lead meetings for The Nevada Assembly or Clark County Assembly. Anyone who is on a timeout, must not be allowed to run meetings and conduct any further business on behalf of The Nevada Assembly or Clark County Assembly.
11. You must ensure any Nevada or Clark County Assembly funds or donations used to send unauthorized notices or to make any other unauthorized purchases must be repaid to our State treasurer.

Please let us know within one week how you plan to proceed. Thank you in advance for helping us bring Nevada back to the peaceful and productive State we once were.
